Introduction

CEIAG has an important contribution to make to the education of all students in order to make an effective transition from school to adulthood and employment. The Academy will provide a range of opportunities for students to learn about work, the world of work, the skills required for work and the qualifications pathways available to them. Well thought-through decisions about learning and work informed by effective CEIAG can increase participation in learning and, in turn, raise attainment and support further progression.

- To prepare students for transition to Further Education or employment with training
- Maintaining and developing effective links with key partners, including Careers Connect, Riverside and Cronton colleges

Review and Evaluation:

The Careers Leader, Principal and Governing Body will be responsible for monitoring, reviewing and evaluating the programme of activities through a range of methods:

- Regular meetings for informal feedback and discussion with the Principal and Vice-Principal
- Teacher, student and parental responses to events and activities.
- Analysis of the destination data and student tracking documentation.
- Career guidance interviews and mentoring feedback with Career Connect.
- Students' evaluation form, which allows students to review and comment on the CEIAG programme.
